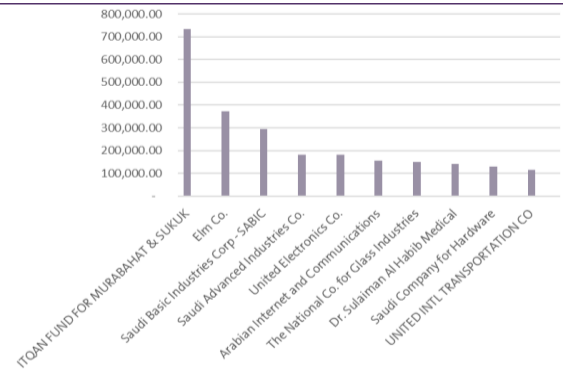

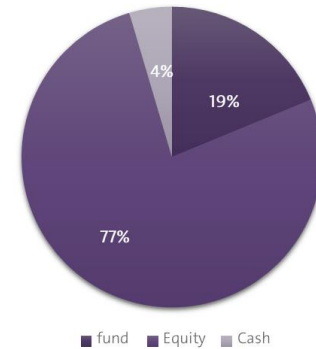

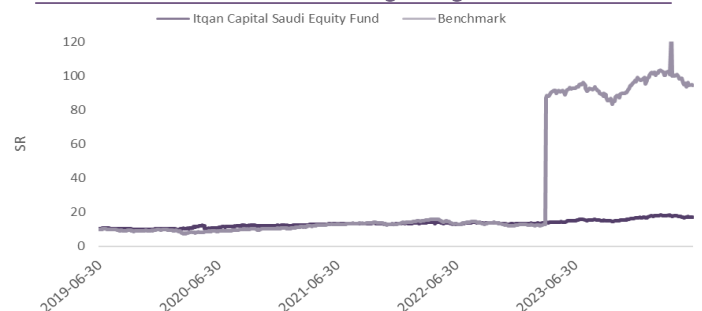
Fund's asset distribution:
